





# OUR PATIENTS

# PAIN FREE AND BACK ON TRACK

After having insurance for over 32 years, Nisa was no longer able to afford the high premium costs and was in need of medical care. With no insurance, Nisa sought other options and found the Clearwater Free Clinic online.

"From the very first visit, I was amazed," Nisa said. "The staff and volunteers go above and beyond to make their patients feel very comfortable and well-taken care of."

Nisa came to the clinic with a meningioma (a benign brain tumor) that was being monitored by her previous providers. After losing insurance, Nisa had not received any follow-up MRIs since 2021. The Clinic ensured Nisa received an MRI and learned the mass had grown in size. The meningioma caused headaches, nausea, and vomiting. Currently, our clinic physicians are working with our neurosurgery partners to remove Nisa's tumor--free of cost.

Nurse Practitioner, Corey Shapiro, partnered with BayCare Medical Group's Pain Management Program to provide Nisa with a personalized pain treatment strategy. BayCare's Dr. Danya Godoy prescribed lower back injections that relieved Nisa's lower back pain. Nisa's pain was initially unbearable, but with treatment and care, her pain is barely recognizable.

"When I had insurance, I had all these existing problems but nothing was being done about it because I couldn't afford the out-of-pocket expenses," Nisa said. "In the short span of time since I started coming here, all the help I needed starting falling into place."

Recently, Nisa has experienced some extreme financial difficulties that impacted her mental health. She was referred to our Behavioral Health Program and began seeing MSW Intern, Danielle Abali.

"Danielle has really helped me feel like I shouldn't give up," Nisa said. "I've always worked in survival mode, especially with my recent financial circumstances, but she encouraged me to slow down and find my enjoyment."

Nisa has taken up journaling, yoga, and breathing exercises to assist with her mental health status. Despite her circumstances, Nisa is grateful for the Clinic for helping her maintain a positive outlook and get her health back on track.



Michael has always considered himself to be in good health. Shortly after moving to Clearwater from Raleigh, NC, Michael was hospitalized for four days after a traumatic fall. The Morton Plant medical staff discovered Michael had uncontrolled diabetes and hypertension, high cholesterol, and anemia.

"When you go into the hospital and you're told you have a blood sugar of 395, your vitals are out of whack, and you have no insurance, you're terrified," Michael said.

Assuming he was in good health, Michael never saw the need to seek out a medical home. He was also unable to afford medical insurance with a Doordasher's income and a lack of veteran's benefits.

A nurse at Morton Plant hospital informed Michael about the Clearwater Free Clinic and the services we provide. After registering as a new patient, Michael worked with Dawn Greene-Putulin, ARNP, and Healthy Living Coach, Georgeann O'Leary to regulate his diabetes.

Despite their best efforts, our clinical staff was unable to completely improve Michael's health and manage his chronic illnesses due to his alcohol consumption.

In the span of five days, Michael passed out three times--once during his appointment at the Clinic. Realizing his health would not fully improve, Michael took the steps to stop drinking.

"I was able to quit drinking because of a lot of encouragement from the people here at the Clinic," Michael said. "They didn't browbeat me, but they just let me know that my health would get a lot better if I quit."

Michael has been sober for over three months and has attended over 122 AA meetings. Immediately after he stopped drinking, Michael's strength and energy improved and his positive outlook on life returned.

As a result of his efforts to improve his health he has lowered his blood sugar to 111 and his A1C to 6.3. He has also been an active participant in the My Heart, My Health class, learning about good nutrition and lifestyle habits.

"Without this place I know I would be closer to death," Michael said. "My goal now is to stay as healthy as possible and live for my five children and 10 grandchildren."

The Clearwater Free Clinic is grateful for contributions made by the **Schoenbaum Family Foundation** which allowed us to purchase Continuous Glucose Monitors (CGM) for patients like Bonnie.

Diagnosed with diabetes over 20 years ago, Bonnie struggled to regulate her glucose and manage her symptoms. Because of the Schoenbaum Family Foundation, Bonnie was given a CGM at no cost to her.

"After a while, it gets so sore sticking yourself three times a day," Bonnie said. "My Healthy Living Coach said 'No, we'll get you a CGM.' It's amazing what a difference that makes."

Thanks to a generous grant from **Community Foundation Tampa Bay**, the Clearwater Free Clinic can continue to expand our Behavioral Health Program with different therapy classes. These classes include art therapy, music therapy, and a women's support group.

Isabel was referred to the Behavioral Health Program after expressing some stress and anxiety. She found interest in the Clinic's Art Connections class which allowed her to learn new art techniques and express herself in a positive way.

"It was amazing because it was so relaxing and I was able to do different art projects," Isabel said. "I was unsure if I could do it, but after the results, I felt more confident in myself."

# A STRONG SURVIVOR'S HEART

After a referral from a friend, Ruth came to the Clinic in 2012 with several chronic diseases, including COPD, liver mass, knee pain, blurry vision and fatigue.

In 2022, during a visit with Corey Shapiro, ARNP, Ruth displayed COVID symptoms and off-handedly commented on her intense ear pain and ringing. After isolating and recovering from COVID, Ruth was seen by our volunteer ENT specialist, Dr. James Chow, who discovered a large mass on her tongue.

Ruth was then referred to BayCare ENT, Dr. John Morrow, who ordered imaging and a biopsy of the mass and directed her to BayCare oncology with Balil Salame, MD.

"All the people who work here have been very helpful in guiding me in the right direction." Ruth said. "When I found out about my cancer, they helped me establish myself with the right doctors and maneuver through it both mentally and physically."

In a short time span, Ruth's mass grew rapidly and began to obstruct her airways and cause difficulty breathing. After being sent to Mease Countryside ER for a viral infection, Dr. William Reschly made plans for a G-tube placement and an extensive 7-hour surgery that would remove the mass and reconstruct her tongue with a skin graft from the forearm and thigh.

Through community partnerships with BayCare and the Community Dental Clinic, Ruth was able to receive a much needed surgery, dental extractions, and follow-up radiation and chemotherapy. Our Clinic providers and partners maintained effective communication and collaboration to ensure Ruth received the best care.

After being dropped from Medicaid and unable to afford healthcare costs, the Clinic stepped in to continue to support Ruth's healthcare journey.

Despite her ongoing chronic disease and cancer management, Ruth has maintained a survivor's heart. The Clinic's Behavioral Health Program and the support of her friends and neighbors has also been instrumental in supporting Ruth with her mental health.

"My next goal personally is to be able to eat again and get my tongue to work," Ruth said. "I'm a strong a woman, I know I was built strong. I'm going to live happy because I've been blessed by the people here."

On March 31, 2023, the Clearwater Free Clinic purchased 1212 Court Street, our new Wellness Annex, with generous funding from one of our long-time donors, the **Ruth & J.O. Stone Foundation.** 

Plans for the 8,500 sq. ft. building include space for a comprehensive Wellness Program, which includes education and meeting rooms, a workout and gym area, and a teaching kitchen. Also housed in the new building will be a Food Clinic, run by Baycare, to provide our patients with healthier and nutritious food options that would otherwise be too expensive and costly to purchase.

New Patient Registration and Development will also be housed in the new building to allocate additional space for more clinical services in the 1218 building. Plans are underway for a remodel and renovation project in the fall.

We are so grateful for this transformational gift! The new wellness program will allow the Clinic to focus on preventative care and be proactive about our patients' health instead of just treating illnesses.
